IMPORTANT INFORMATION REGARDING YOUR PERMIT/APPLICATION

- ◆ Allow three (3) business days for your application to be processed.
- ◆ Upon approval, permit fees must be paid within 180 calendar days or the application may be considered void and require resubmittal. The permit is not valid until full payment is received.
- ◆ Upon approval and payment, permit is valid for 180 days. If permit expires, an extension may be granted with a written request. If work does not commence within the 180 days or is suspended, the permit becomes null and void. No refunds will be given for expired permits.
- ◆ No trade permits will be granted on new construction projects or work requiring remodel permits until the general building permit is valid.
- ◆ Separate permits are required for plumbing and gas work unless specifically approved by inspector.
- ◆ Current licensing and insurance status will be confirmed with the Texas State Board of Plumbing Examiners prior to issuance of permit.

REQUIRED FOR FINAL INSPECTION APPROVAL

- ◆ Water heaters installed in new construction require a thermal expansion tank.
- ◆ Electric water heater installations/repairs must be brought up to code, which states that a disconnect must be provided.
- ◆ Tunneling under slab may require a letter or report from an engineer prior to final approval of work.
